FINAL PAYMENT UPON DEATH - RETIREE BENEFICIARY FORMS

Oftentimes, when a retiree passes away, their bank account closes before we can deposit the final monthly benefit payment due to them. When a deposit is rejected by the bank, StanCERA is notified of the account closure. You can make sure this final payment goes to your preferred beneficiary(s) by filling out our Final Benefit Payment Upon Death form, located on our Forms and Publications / Retired Members page. We will soon be mailing forms directly to those who do not have a Final Benefit Payment Beneficiary on file. Completed forms can be emailed, mailed, or dropped off in-person.
